### Partial amendment of rules of Middle Marches Community Land Trust Ltd.

#### Delete the wording Rule G14.1 and substitute with;

If on the winding-up or dissolution of the Society any of its assets remain to be disposed of after its liabilities are satisfied, these assets shall not be distributed among the members, but shall be transferred instead to some Charity or Charities having objects similar to or compatible with the objects as may be decided by the Directors and recommended and approved by the members in general meeting.

### Delete Rule G14.2, and Rule G14.3

### Delete the wording of Rule G15.21, and substitute with:

"Charitable Purpose" means a charitable purpose under section 2 of the Charities Act 2011;

"Charity" means a body which is charitable for the purposes of the law of England and Wales and which in particular:

- has exclusively charitable purposes
- is operating for the benefit of the public
- has a governing document which restricts the adoption of any purposes which are not exclusively charitable in nature
- has a governing document which provides that, on dissolution, any residual assets of that body must be passed to another Charity

And Charities shall be construed accordingly.
